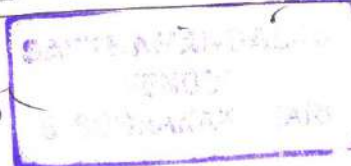

FINANCE

Regarding the financial arrangements during the Project implementation, Energy Management Centre-Kerala and Department of Physics, All Saints' College, Thiruvananthapuram further agree to:

- a. Both parties will engage services of the existing employees for the Programme and no additional staff will be provided.
- b. Both the partners will utilize existing infrastructure for industry-academic interaction arrangement.
- c. All expenses in connection with implementation and monitoring of the courses, Honorarium, TA/DA and other organizational expenses of both parties will be borne by the fund collected as fees from the participants.

INDEMNITY

Both parties hereby indemnify and shall keep indemnified and protected the other party and their respective officers and employees from and against any claims or actions arising out of or in any way relating to the provision and implementation of the Programme as per this MoU.

DURATION

This MoU will be active for a period of four years from the date of this MoU. It will be extended for further period by mutual consent.


TERMINATION
