

short the Commission) represented by the Secretary on the other part.

Whereas administrative sanction has been accorded by the Government to  
Kerala Women's Commission to utilize Rs. 9 Lakhs for conducting research studies  
under plan fund 2021-22 as per GO(Rt.) No.416/2021/SJD dated 13/06/2021.

And whereas the commission in its meeting held on 08/07/2021 has decided to  
conduct major/minor research studies utilizing Rs. 9Lakhs allotted by the  
Government under plan fund.

And whereas the commission has decided to implement the said work through  
experienced and qualified agencies/individuals in the respective fields.

And whereas the commission has selected the Bounden as a candidate and  
decided to allot the work of conducting research study on the topic **"Dowry Deaths  
in Kerala"** to the Bounden as per the decision of the Commission in its meeting held  
on 08/07/2021 with an estimated amount of Rs. 2,00,000/- for the study.

And where as the Commission has decided to sanction a sum of Rs.50,000/-
