<u>A GREEMENT</u>

Whereas administrative sanction has been accorded by the Government to Kerala Women's Commission to utilize Rs. 9 Lakhs for conducting research studies under plan fund 2021-22 as per GO(Rt.) No.416/2021/SJD dated 13/06/2021.

And whereas the commission in its meeting held on 08/07/2021 has decided to conduct major/minor research studies utilizing Rs. 9Lakhs allotted by the Government under plan fund.

And whereas the commission has decided to implement the said work through experienced and qualified agencies/individuals in the respective fields.

And whereas the commission has selected the Bounden as a candidate and decided to allot the work of conducting research study on the topic "Dowry Deaths in Kerala" to the Bounden as per the decision of the Commission in its meeting held on 08/07/2021 with an estimated amount of Rs 2,00,000/- for the study.

And where as the Commission has decided to sanction a sum of Rs.50,000/-(Rupees Fifty thousand only) (ie 25% of the total amount) as advance to the bounden which shall be adjusted in the final bill subject to all the terms and conditions prescribed in the notification inviting application for the Research Study by the Secretary, Kerala Women's Commission.
