5. Party shall neither assign nor transfer its rights and obligations herein to any third party without prior written consent of the other party.
6. None of the parties shall withdraw from the agreement during the duration of the assignment in hand without the written consent of the other.
7. In the event of any dispute between the parties the same shall be resolved amicably. The venue of the arbitration proceedings will be at Thiruvananthapuram and the cost involved for the arbitral proceedings will be equally borne by both the parties. The arbitral proceedings will be conducted as per the Arbitration and Conciliation Act, 1996 (26 of 1996) as amended by the Arbitration and Conciliation (Amendment) Act, 2021 (3 of 2021) and the parties agree to abide by the award of the Arbitral Tribunal as final and binding on them.
8. Rights Cumulative: The rights and remedies set forth in this agreement are cumulative and not mutually exclusive and are in addition to any other rights or remedies which may be granted by law or available inequity.
9. Modifications: The terms of this agreement shall not be modified without a written agreement entered into by both sides.
10. Legal Liability: M&C shall hold the entrusted processes, as per this agreement, in a free, fair and transparent manner to avoid any room for complaints. In the event of any challenge to the activities undertaken by M&C under this agreement before any Courts/Tribunals/other Authorities, the M&C shall not only defend the part of the activities handled by it but also support All Saints' College to defend the process by supplying all relevant documents, materials etc. as are in M&C's possession and by offering the affidavits or oral evidence of its concerned officers before the concerned Courts/Tribunals/other Authorities, at the request of All Saints' College.
11. Indemnity: M&C shall take all reasonable steps in conducting the Legal Awareness Training programme entrusted to it with utmost care and due diligence.
12. In case of any issues/comments/ regarding legal resource material that are to be updated/rectified the same will be rectified by M&C without claiming any extra fees/cost from All Saints' College.
13. M&C reserve the right to monitor the legal content of the Legal Awareness Training and exercise the sole authority to decide the name and designation of resource persons from various resource organizations for each session as well as date, time and venue of the session(s) subject to the convenience of the All Saints' College.
14. M&C and All Saints' College are joining hand in hand to promote Legal Awareness among student community and neither parties will not claim any monetary damages against each other for any shortcomings/failures in executing the project/assignment during the agreed upon academic years and undertake to extent the said assignments even after the expiry of the MOU on mutually agreeable terms and conditions by the parties.

All Saints' College and M&C jointly would be in process of issuing certificate(s) to student(s) who have successfully completed the session(s) and the said certificate(s) will carry the logos of M&C, All Saints' and the technical knowhow resource person's organization if any, who would have been involved in delivering the session conducted in batches.
